 - **General Public Comments**
 - **Approval of Meeting Minutes**

 - **Report of the Superintendent**
 - On a motion made by Dan Wade seconded by Renee Marchesseault, the Board denied the parent request for moving expenses dated November 18, 2021; vote 5-0.
 - On a motion made by Linda Harris seconded by Renee Marchesseault, the Board denied the Parent Request for Additional Language in the Student Handbook related to Extracurricular Activities dated November 22, 2021 and the decision will be deferred to the Principal on an as needed basis; vote 4-0-1.
 - On a motion made by Dan Wade seconded by Krista Rodrigue, the Board approved the Adult Meal Lunch Price Increase memo dated December 1, 2021; vote 5-0.
 - **Report of the Principal and CTE Director**
 - Reviewed Principal's Report dated December 7, 2021 with academic data point summaries for assessments, attendance, counseling, and discipline.
 - Reviewed the CTE Director's Report dated December 8, 2021 with the recommended name rebranding of the Career Center to Northwoods Technical Center.
